## Dual-Fuel Heat Pump Rebate Qualification Standards

### **Eligibility:**

- Only Palmetto Electric Cooperative, Inc. members are eligible.
- Residential existing and newly constructed homes are eligible.
- One rebate per home is available for installation of a Dual-Fuel Heat Pump.

### **Dual-Fuel Heat Pump Equipment:**

- Only Dual-Fuel Heat Pumps (DFHP) will qualify.
- Each DFHP system must include: new heat pump outdoor unit matched with a new indoor unit and new gas furnace.
- The system capacity must be determined by an ACCA Manual J load calculation.
- Each system must be controlled by an outdoor sensor that shall prevent operation of heat pump compressor below the temperature (**38 degrees**) specified by Palmetto Electric.
- Equipment must be capable of complete automatic switching from heat pump mode to supplemental gas heating.
- The use of supplemental electric resistance heaters is not permitted.
- All equipment must be properly matched and AHRI rated.
- Equipment must be installed by an approved HVAC contractor.
- The HVAC contractor must hold a valid S.C. Mechanical Contractor license.
- Installations must be in compliance with all state and local codes.

### **Rebate Details:**

- \$500 rebate per system is available for installation of Dual-Fuel Heat Pumps.
- Rebate will be mailed to homeowner within 4 to 6 weeks of application date.
- A copy of the sales invoice must be included with the application.
- The application must be completed in full including all model and certificate numbers.
- The equipment must have been installed within one year of the date of application.
- The homeowner must allow for an inspection by Palmetto Electric representative to ensure compliance with the program standards.
- Palmetto Electric Cooperative does not, in any manner, warranty or guarantee any Dual-Fuel Heat Pump system installed under the terms of this program and does expressly disclaim any responsibility for the proper installation and/or operation of any system(s) installed.
